If you have already paid the entire amount for 2018, thanks so much for doing this early in the year. We appreciate the efforts of every church in our District toward meeting their goal of 100% in 2018.

Update on Insurance Rates for January 1, 2019

Annual Conference voted to change the proposed insurance amendment presented to the Conference.

The section on prescription drug coverage was presented as: "30% or \$35 whatever is greater" was accepted as "will have a cap of \$100 on the 30%" which has resulted in an increase in rates for both church and pastor starting on January 1, 2019. There is also a change in the Medicare Supplement from \$135 to \$162 per month. Our insurance plan has not had any changes in 9 years and this is a tremendous record for no increases when private insurances have been increase quite steadily each year. Please look at this and plan for the increase with your financial committees. The deductibles have changed for 2019 also. \$2000 for individuals and \$4,000 for families. Churches, if you have employees who do not work 30 hours per week, they cannot be on Conference Insurance Plan. The other change was: If your spouse can purchase insurance from their employer, they cannot be on our Conference Insurance Plan. All of these changes will save the conference a lot of money on the insurance program. It was necessary to make these changes.

If the Pastor is on their spouse's insurance plan and the church agrees to pay a portion of the premium, this amount goes on Line 10 and is counted as salary and will be taxed. The District Office needs to know if this is the case and the amount being paid.

From the District Superintendent

Local Pastors are not licensed beyond their local church. You must have permission from the Bishop to perform a marriage ceremony in another church under another pastor. Full Elders must get credentialed through the state they will officiate in if they are asked to do a marriage ceremony in another state. WV is through the Secretary of State office.

Every Trustee must be bonded to \$25,000.

Every Treasurer must be bonded to \$25,000. Please send insurance proof to the District. A 1099 MUST BE GIVEN FOR MOVING EXPENSES PAID BY THE CHURCH FOR THE PASTOR.

Every person in the local churches (including Pastors) working with children must go to a Sexual Ethics Training every 4 years. This is a NEW POLICY.

Local Church Trustees are responsible if a church does not carry adequate insurance and liability.

Churches need to pay Worker's Compensation on all their employees. This will cover your workers in case of a fall or injury at the church/property.

Every church/charge MUST HAVE A PARSONAGE INSPECTION ANNUALLY, AT THE LEAST! The Pastor cannot fill out the charge conference parsonage inspection form by him/herself. Must have the parsonage trustee chair, PPRC chair, pastor, at the least.

Charge Conference material must be in the district office ONE week ahead of time with ALL SIGNATURES!

On Salary Sheets, the PPRC and Pastor must meet and fill out the right hand column of the compensation worksheet (salary sheet). Then call the district office and notify us of all changes. We have a macro to fill out the salary among all churches on your charge. If percentages change, please let us know. The completed salary sheet will be sent to you for signatures and for use at charge conference. Please make 3 copies of all papers, one for Pastor, one for D.S., and one for Charge Conference Secretary, who will be attending the meeting. Insurance rates have risen for 2019 and are included in the charge conference materials. ALL Treasurers should receive copies of Salary Sheet and Fair Share sheet which has your apportionment for each church and their Promotional Fund Amount, and amount of Educational Fund assessment, based on your membership at that church.

Dear Friends of the West Virginia Conference,

This week, the Council of Bishops met in Chicago to receive the final report from the Commission on a Way Forward and discern the recommendation that would be sent to the special session of General Conference to be held in St. Louis, MO in February of 2019. This meeting was bathed in prayer, dependent on the movement of God's Holy Spirit, and marked by caring and honest conversation.

At the request of the 2016 General Conference, a 32-member Commission was appointed by the Council of Bishops to assist the bishops in their charge to lead the church forward amid the impasse related to homosexuality. The Commission on a Way Forward was asked to explore, design, and recommend a way for being Church that maximizes the presence of a United Methodist witness around the globe, allows for as much contextual differentiation as possible, and creates as much unity as possible. The work and report of the Commission was based upon the Vision, Mission, and Scope that was given to the Commission to guide its work and included three possible models for moving the church forward.

Following intense prayer, discussion, deep discernment and with deep appreciation for the work of the Commission, the Council of Bishops made and affirmed the following motion.

Motion

Having received and considered the extensive work of the Commission on a Way Forward, the Council of Bishops will submit a report to the special session of the General Conference in 2019 that includes:

- All three plans (The Traditionalist Plan, The One Church Plan and the Connectional Conference Plan) for a way forward considered by the Commission and the Council.
- The Council's recommendation of the One Church Plan.
- A historical narrative of the Council's discernment process regarding all three plans.

Rationale:

In order to invite the church to go deeper into the journey the Council and Commission has been on, the Council makes all the information considered by the Commission and the Council of Bishops available to the delegates of the General Conference and acknowledges there is support for each of the three plans within the Council. The values of our global church are reflected in all three plans. The majority of the Council recommends the One Church Plan as the best way forward for The United Methodist Church.

The Council's discernment process was guided by the over-arching desire to strategically help the General Conference do its work and to honor the General Conference's request for the Council to help the church find a way forward. Therefore, while the Council of Bishops made a recommendation for the One Church Plan, the Council felt it was very important to include all three models worked on by the Commission on a way Forward as a part of the report to the February 2019 called session of General Conference.

The report will go through a final process of perfection and revision that will take several weeks. Following this process and before the report can be publicly released, it must be translated into the official languages of the General Conference. Therefore, the full report will be made public no later than July 8.

Following the date of release, the members of the West Virginia Delegation will be working to set up gatherings in our Districts for continued conversation and prayer. Ultimately the decision on this matter lies with the 800+ clergy and lay delegates from around the world who will convene at the General Conference in St. Louis in February 23-26, 2019.

These are indeed critical and anxious days for our beloved United Methodist Church. Yet, let us remember Jesus is Lord of the Church, the mission of the Church is clear, and our calling and opportunity to use the gifts of God's Holy Spirit remain. Indeed, God's promises endure: God will be with us; God will protect us; and God will bless us! We can trust in these promises!

Let us pray and not be paralyzed, let us hope in the midst of our uncertainty, let us care for one another in the midst of hurt, anxiety or confusion, and let us love one another in the midst of disagreement. Additionally, may God inspire us and bless us as we continue to be the church, a church which effectively, and fruitfully brings hope to the world, while continuing to fulfill the Great Commandment and the Great Commission to make disciples of Jesus Christ who work together with one another in ministry that is empowered by God to transform this world into the likeness of Christ.

May it be so. I look forward to continuing our ministry and mission together and to celebrating how God is working through the West Virginia Conference clergy and laity to bring hope, healing, and life to the world.

Wesleyan District Committee on Lay Ministry

Hello fellow Lay Servants! (...and, of course, Pastors and Laity of the Wesleyan District)



It's that time of year again - time for our Fall Lay Servant Ministry Academy!

I know that there have been many changes to Lay Servant Ministries over the past few years, and you still might be uncertain as to where Lay Servants fit into the overall structure. I took a look at your class records that we have in the District office, and I see that several of you are very close to taking all of the classes you

need to certify as Lay Speakers, so let's talk about what we currently need to get certified or stay in line with the guidelines from the 2016 Book of Discipline.

Anyone who wants to be a Certified Lay Servant at any level must first take the basic Intro to Lay Ministry course. If you took this course prior to 2012, you will need to take the current course. Once you have completed the basic course and have taken one advanced course, you have earned the title "Certified Lay Servant."

For those wishing to proceed to become a Certified Lay Speaker, you must then take the Advanced Speaking/Preaching class. Once you complete this course, there are five other advanced courses that are required to become certified as a Lay Speaker – currently Leading Worship, Leading Prayer, United Methodist Heritage, Discovering Spiritual Gifts, United Methodist Polity, and Caring for Those Who Grieve.

After completion of these courses, you must fill out the Report of the Lay Servant to the Charge Conference (which is included in your church's charge conference paperwork each year), indicating your intended status. This will be reviewed by your pastor/SPRC and a recommendation will be made to the District, via your charge conference. Once approved at your charge conference meeting, your report will go to the Wesleyan District Committee on Lay Ministry for final sign-off.

As you are probably aware, there is one more designation that laity can pursue in Lay Servant Ministries.

The Certified Lay Minister is a relatively new tract for those interested in becoming assigned supply or filling the pulpit in a more formal way. It requires a four module course of study and appearance before the District Committee on Ministry for approval. If you are interested in learning more about this program, you can visit our website at www.wesleyandistrictumc.org or contact me.

OK, back to this year's Academy! If you look at the enclosed brochure, you will see that we are offering a new advanced course on Stewardship, being taught by our District Superintendent Rev. Mary Ellen Finegan. It really looks to be a great class, and we hope that you consider taking this course as one of your elective advanced courses.

Remember that all lay servants or lay speakers need one advanced course every three years to stay certified, but you can take one more often if you choose!

I hope this helped clarify some of the requirements or questions you may have had about Lay Ministries.
